INCIDENTS

1/22/24 – 8700 block Duveen Drive – Springfield Police along with the Wyndmoor Hose Company, Flourtown Fire Company, Oreland Volunteer Fire Company, mutual aid from additional Fire Companies, and the Community Ambulance Association of Ambler were dispatched to the area for a fully involved house fire. Fire crews were able to get the fire under control after a period, however tragically there was a fatality to the resident. This incident is under investigation by the Springfield Township Fire Marshal's Office.

1/22/24 – 1400 block Bethlehem Pike – Officers were dispatched to the area for a reported physical fight in progress involving an adult and a juvenile. Officers quickly arrived on scene and requested EMS for evaluations. Ultimately, the juvenile was taken into custody for aggravated assault.

1/23/24 – 200 block S. Easton Road (Cheltenham Township) – Several Springfield Officers were dispatched to assist the Cheltenham Police after an "Officer Needs Assistance" call was broadcast. Springfield Units were quickly resumed prior to their arrival as the Cheltenham Police were able to get the suspect under control. This incident is under investigation by the Cheltenham Police Department as they are the agency having jurisdiction.

1/23/24 – 2100 block Church Road – Officers were dispatched to the area after a resident reported a male sitting on their front porch. Responding Officers were able to contact the male and provide a courtesy transport. The male was checked for wants/warrants which were negative. and he was then sent on his way.

1/25/24 – 2100 block Pennsylvania Avenue – Officers were dispatched to the area for a physical disturbance after an adult male attacked another adult party. Responding Officers were able to separate both parties and take the male offender into custody for aggravated assault.

1/26/24 – 2700 block Cheltenham Avenue (Cheltenham Township) – Springfield Officers responded with the Cheltenham Police Department to a reported robbery in progress at gun point. The suspect fled the store prior to Officers arriving at the scene. Responding Springfield Units assisted with canvassing the area for the suspect and were quickly returned to normal patrol operations. This incident is under investigation by the Cheltenham Police Department as they are the agency having jurisdiction.
