#### Agenda Item:

**PC1:** The Board of Commissioners have forwarded the request for a waiver of the land development requirements, filed by Steven N. Kline, AIA, the design professional for the project, on behalf of Burke Brothers Landscaping Contractors, Inc., owners of the property located at 7630 W. Cheltenham Avenue. The owners propose to relocate the company's offices to an existing warehouse on the site. A second floor addition is proposed to the warehouse to accommodate the office space. The building's footprint is not proposed to be increased and there is no additional impervious coverage proposed. The site has available parking to support the office use. The site consists of 2.14 acres of lot area and is known as parcel #5200-0310-0007 and parcel #5200-0311-2004. The property is zoned within the Industrial District, Limited Industrial District and the B-Residential District of Ward #5 of Springfield Township.

**PC2:** The Planning Commission will continue their review of the on-site parking and parking lot design standards found within the Springfield Township Zoning Ordinance.
