

POLICE COMMUNITY RELATIONS

At a time when police departments across the nation are looking to assess their policies and procedures to maximize community-police engagement and ensure that the services they deliver are both fair and equitable, Springfield Township and the Springfield Township Police



Department (STPD) remain committed to engage in productive dialogue, form strong partnerships with the community and local organizations, and identify meaningful strategies to improve the level and quality of protection offered to all residents.

To conduct a community-wide survey about police-community interactions, a team of local researchers have partnered with the Township, STPD, Multicultural Parents Association of Springfield Township School District, the Cheltenham Chapter of the NAACP, and Temple University. Participation in the survey is completely voluntary and all information provided, including the identity of respondents, will be kept anonymous.

The survey will be conducted primarily in an online format and will be accessible on the Township website (www.springfieldmontco.org) once the survey launches. The survey will also be made available in PDF for those who wish to print and return a completed survey for drop off at the Free Library. Residents are encouraged to complete the survey online to improve the efficiency of the analysis. If you don't have a computer, smartphone or tablet, the public computers at the library can be used to complete the survey. •

TAX COLLECTORS

Three separate entities are responsible for collecting taxes from residents and businesses in Springfield Township. Ms. Bonny Davis, Springfield Township's independently elected Treasurer/Tax Collector, is responsible for collecting real estate taxes for the Township, County, and School District. Berkheimer and Tri-State Financial are professional collectors under contract with the Township to collect income, local service, and business taxes, respectively.

CHIARAMONTE PARK IMPROVEMENTS

In 2020, the Springfield Township Board of Commissioners awarded a contract valued at over \$100.000 for improvements at Henry R. Chiaramonte Park in Oreland. Funded in part by a \$72,000 U.S. Federal Community Development Block Grant, a new rubberized play surface as well as an ADA accessible walkway were installed to increase safety and access to the playground.



The improvements were completed in late 2020 with the addition of new swings to this beloved neighborhood park.

2021 Budget

The Springfield Township Board of Commissioners adopted a balanced operating budget for 2021 of \$17,223,096 with a real estate tax rate of 4.516 mills and an earned income rate of 1.0%.

As a result of the 2021 budget projections, the "typical" residential taxpaver will realize an increase of \$13.15 to their 2021 real estate tax, and an increase of \$8.62 associated with the refuse service fee.



From the Police



Protect or Reduce Your Digital Footprint

Your digital footprint has implications to both you and your loved ones. It can be defined as your unique set of traceable activities and communications on the internet and/or on any digital device. You can try to delete accounts in an effort to erase your digital footprint, but many social media platforms retain your profile data.

Here are a few tips to help residents minimize their footprint and reduce the risk of being targeted by cybercriminals:

- Limit what you share online via social media, online submissions/forms.etc.
- 🔼 Avoid unsafe websites. If a website begins with "HTTP" instead of "HTTPS", reconsider going to that site. The "S" stands for secure.
- Be cautious when connecting to and using public internet/ wi-fi networks.
- Delete what you don't need to save online (like passwords)

The Springfield Township Police Department is trained for and has been investigating cybercrimes for vears. In 2018, one member of STPD was even selected to serve on the U.S. Secret Service's Cyber Fraud Taskforce.

PENNSYLVANIA REVISES "STEER CLEAR" OR "MOVE OVER" LAW

Under the Pennsylvania Motor Vehicle Code, drivers approaching an emergency response area must slow down and should pass in a lane not adjacent to that of the emergency response area. Known as the Steer Clear or Move Over Law. these rules are in place to ensure the safety of emergency responders (i.e.



Police, Fire, EMS, etc.) as well as public motorists. The law was revised in late 2020 to clarify how motorists should react when approaching or passing an emergency response area. Specifically, drivers who are unable to safely merge into an adjacent lane are now required to slow to at least 20 mph less than the posted speed limit.

Other changes include a new point system that imposes two points for failure to merge into the adjacent lane and sets fines at \$500 for first-time offenders, \$1,000 for a second offense, and \$2,000 for a third or subsequent offense. Third time offenders will also receive a 90-day suspension. Additional fines of up to \$10,000 will be assessed to violators who injure or kill an emergency service responder or a person in or near a disabled vehicle. If several traffic violations occur in an emergency response area, fines may be doubled. The revised law takes effect on April 27, 2021.

KEEP PORCH PIRATES AT BAY: USING DOORBELL/ SECURITY CAMERAS

Surveillance and/or doorbell cameras are powerful security tools that discourage crime and helps local law enforcement by providing evidence that could be used to keep our community safe. The Township and Springfield Township Police Department (STPD) strongly supports the use of such devices and encourages those with such cameras to register them with the Safewatch program.



The Safewatch program is a STPD surveillance camera initiative where residents and businesses can register at no cost and share their security camera footage with the police in the event of a crime being committed near their property. By registering with Safewatch, residents can help Police decrease the time between the commission of a crime, to suspect identification and arrest. Participation is strictly voluntary and residents can withdraw from the program at any time. Personal information is confidential and participants will receive a window decal which helps serve as a deterrent to criminals.

Building & Zoning

SPRINGFIELD TOWNSHIP STORMWATER MANAGEMENT PROGRAM

When it rains, stormwater is collected by the Township's storm sewer system and carried directly to the nearby streams and creeks. It is the Township's responsibility to monitor the storm sewer system for pollutants. In the case of stormwater, a pollutant is anything other than rainwater. Below are 10 simple things identified by the EPA that the typical homeowner and/or business owner can do to help reduce pollutants in rainwater carried to our streams and creeks.



- Use fertilizers very sparingly.
- Sweep up driveways and sidewalks: dispose of debris properly. Do not sweep into street gutters.
- Vegetate bare spots in your yard.
- Compost your yard waste.
- Avoid pesticides; learn about Integrated Pest Management (IPM).

- Never dump anything down storm drains.
- Direct downspouts away from paved surfaces.
- Take your car to the car wash instead of washing it in the driveway.
- Check cars for leaks and recycle motor oil.
- 10 Pick up after your pet, even in your own yard.

SPRING CLEANING

Spring is here and our Code Enforcement office has prepared a list of essential tips to help residents spring-clean their properties:

- · Clean and check your rain gutters and downspouts.
- Dispose of downed limbs and brush.
- · Check windows and doors to make sure they are properly sealed.
- · Check your roof or have it inspected by a licensed and insured roofing specialist.
- · Have any damaged or unhealthy tree on your property inspected.
- · Repair any sidewalk or walkway on your property that is a tripping hazard.
- · Have any drainage swale or inlet on your property cleared of leaves and other debris.
- Do not forget to change the batteries in your smoke detectors.
- Call PA One-Call at {811} before you dig on your property or in the public right-of-way.

Renting a Dumpster: DEPENDS ON

LOCATION. Dumpsters are not permitted within the public right-of-ways. If located in a driveway, a permit is not required. If located in the street, permission is required from the Township prior to placement of the dumpster. Contact the Township at 215-836-7600.

Renting a POD: YES. A permit is required.

Please contact Code Enforcement before work on any activity that could require a permit.



Unexpected Consequences of Feeding Wildlife with Guidance from the Pennsylvania **Game Commission**

Decades of research indicates numerous unexpected consequences associated with feeding local wildlife: long term habitat destruction, increased vehicle collisions. habituation to humans, alteration of animal behavioral patterns, increased potential for disease transmission. and reduced wildlife diversity. Animals can also become more aggressive with increased exposure to humans.

Risk to native vegetation:

One of the most prominent consequences of feeding wildlife, especially deer, is an increased risk to native vegetation and biodiversity. Feeding can cause more deer to survive than the local habitat can support, which diminishes the natural carrying capacity of an area. This can put native plant populations at risk and create a ripple effect through the whole food chain. With native plants at risk, non-local invasive plant species can take over a habitat and cause its own share of unintended consequences. In turn, other animal species are also at risk when these changes to the habitat occur.

Increased chance of collisions

and disease: Feeding wildlife also increases the likelihood of vehicle collisions. This can increase the likelihood of injury or even death for both humans and animals. Deer and other animals also carry diseases, such as Lyme, rabies, and many others. Feeding animals can increase exposure to these diseases and thus increase the risk of spread among local human, pet, and other wildlife populations.

DO I NEED A PERMIT?

Putting in a Swimming Pool: YES.

Most also require an electrical permit.

Installing a Shed or Garage: YES.

These require zoning approval for setbacks and height.

Replacing or Putting up a Fence: DEPENDS ON HEIGHT AND

LOCATION. A permit is not required for fence work, however, height restrictions apply. Contact the Township.

Curbside Leaf Waste Collection

The Township's residential curbside leaf waste collection program runs from late March through December with a special collection week at the end of February - weather permitting.

Leaf waste includes leaves. garden residues, shrubbery, tree trimmings, and similar material. Residents should place their leaf waste in a biodegradable paper bag or securely tied and bundled (so as not to exceed 4 feet in length nor 50 pounds in weight) at their curbside by 7:00 AM on their regular collection day.

NOTE: Grass clippings are not leaf waste. Please do not include grass with your leaf waste. Place grass in cans or plastic bags for regular Refuse collection.

Fifteen (15) bags of leaf waste will be collected on a weekly basis. To the extent that additional bags are placed at curbside for collection, the Township will make reasonable efforts to remove them in a timely manner. The bags are not to exceed 50 lbs. in weight.

Leaf waste generally gets collected later in the day after the crew finishes Refuse collection.

You are encouraged to voluntarily compost leaves and garden debris in an environmentally responsible manner, including home-based composting and grass-cycling.

Composted leaf waste (mulch) is available to our residents free of charge at our W. Wissahickon Avenue site (opposite the entrance to Mt. Saint Joseph's Academy).

Please be advised that Chapter 92-18 of the Springfield Township Code prohibits the depositing of leaves or material of any kind in any gutter or upon any street or highway within the Township.

REFUSE & RECYCLING INFORMATION

2021 SPRING / SUMMER HOLIDAYS

Trash and recycle will not be collected on these holidays. Trash and leaf waste will be collected the following business day, and recyclables should be held until the following week.

Refuse, recyclables and leaf waste must be placed at the curb, in front of premises, no earlier than 7:00pm on the evening prior to collection and no later than 7:00am on the day of collection.

Within eight hours of collection, containers must be returned to the household. Please locate refuse and recyclables a suitable distance apart from one another at the curbside so that the proper truck can identify your materials.

HOUSEHOLD RECYCLING REGULATIONS



GLASS: All colors. (NO ceramics, light bulbs. plate glass, head lights, mirrors, windshields or glass blocks).



CANS: Aluminum beverage cans and bi-metal cans.



PLASTICS: (#1 through #7) containers including soft drinks, water bottles. milk jugs, detergent bottles and food/yogurt.



NEWSPAPER. MAGAZINES. JUNK MAIL. OFFICE PAPER. COMPUTER PAPER, TELEPHONE BOOKS, CORRUGATED CARDBOARD AND PAPERBOARD containers including cereal boxes, cracker boxes, and cartons from beer and soda (with no waxy coating) - are recyclable. Please remove contaminants such as trash, food waste, styrofoam, plastic and all other packing materials.

- Recyclable materials may be combined in one can or container not to exceed 32-gallon capacity 50 lbs. in weight. Please do not place recycled items in plastic bags!
- New and replacement recycling containers are available at the Township Administration Building for \$15 (cash or check only).
- Place all acceptable recycling materials at vour curb, separate from refuse materials. for collection on your regular collection day.



The Commissioners also authorized the purchase of two new hybrid vehicles instead of traditional (internal combustion engine) models for the Springfield Township Police Department as part of the Township's annual vehicle replacement plan.




STREET AND SIDEWALK OBSTRUCTIONS

OVERHANGING VEGETATION

All overgrown trees, shrubbery and/or vegetation on your property overhanging the sidewalk or the street should be trimmed to provide a clear and unobstructed path. Springfield Township Code, Section 92-15, requires that all walkways, sidewalks or roadways be free of any obstructions. This clearing is the property owner's responsibility.
