Agenda Item:

PC1: Representatives from **LaSalle College High School** will present several renderings of a proposed 7,000 square foot, single story addition to the existing academic wing of the main building. The proposed addition will house the existing David's Program. The David's Program provides special instruction to students in need. The proposed addition will not require any additional staff nor will there be any increase in the student population. The property is zoned within the Institutional District of Ward 7 of Springfield Township.

PC2: Representatives from MEH Investments, LLC and 380 Haws, LP will present a rendering for a three story, 69,510 square foot building to be used as a behavioral health facility. The building is proposed to be centrally located on the site, with parking along the frontage and both sides of the proposed building. The rendering lists the proposed building as 42 feet in height and the site is proposed to contain 93 on-site parking stalls. The rendering also plots the location of an on-


Public Notice Planning Commission Meeting Sketch Plan Review

This notice is sent to inform you the Springfield Township Planning Commission will hold a public meeting on Tuesday, November 16, 2021 with a 7:00 P.M. start time to discuss an informal Sketch submitted by LaSalle College High School for a proposed single story, 7,000 square foot addition on the campus located at 8605 Cheltenham Avenue, Wyndmoor, PA 19038

LaSalle College High School will be presenting the renderings of the proposed addition to the Planning Commission in the hopes of receiving comments from both the Planning Commission and the surrounding property owners. The proposed single story addition is projected to house the existing David's Program. The David's Program provides academic support to roughly 60 to 65 existing students in need of this specialized teaching environment. The proposed addition will not increase student population on campus or require the hiring of any additional teaching staff.

Public Notice Planning Commission Meeting Sketch Plan Review

This notice is sent to inform you the Springfield Township Planning Commission will hold a public meeting on Tuesday, November 16, 2021 with a 7:00 P.M. start time to discuss an informal Sketch submitted by MEH Investment Group & 380 Haws, L.P. for institutional development of the properties located at 380 Haws Lane and 402 Haws Lane, Flourtown, PA 19031.

The applicant and owner of the site have submitted a rendering of a proposed single building consisting of 69,510 square feet, 42 feet in height to treat as many as 88 individuals, which will be used for institutional use. No additional information has been submitted at this time. This is an informal review by the Springfield Township Planning Commission. No other applications have been submitted for this site. The Planning Commission and the public will have the opportunity to review the plan and provide comment on the proposed layouts and use of the site.
