### **Old Business**

- Review the advertisement of the bag ordinance, its current status and what happens next for the board vote on it and then the activities of the program guide for the implementation assuming a positive vote.
- Solar education still more work to be done. Push to October or November from the original.
- Heat Pump presentation Stephen to follow up w/ Steve Campbell on doing it. There Rex Plumbing, Ryan, who also has expertise in this. Aaron John Prost who specializes in whole home electrification, does a lot of consulting. Has an interest in doing that.
- Home electrification shift this from Stephen to John Prost to set that presentation up.
- Muni buildings update Target September for the next update. Over \$200k of savings over 2 years and 150k of CO2 emissions. New system in place for getting the PECO bills in place to Pat to keep tracking that. Looking for more data on the savings of the Hybrids. They've already saved the cost of buying a new hybrid.
  - Desiree needs the fleet information after the end of the year.
- Rec center planning update on the former Seven Dolors site. Pitch from us is for it to be a net-zero building. Which has been well received by board and the rec center committee. Wants to bring in Practical Energy solutions to that process.
  - Joy would like the EAC to draft a letter in support of this, will pick this up in September.
    One aspect of the rec center should be air quality, especially if it will function as a shelter. Kathy Wilde has an offer on the table to present to us as a leed certified practitioner.
- Working with other municipalities Joy invited to a podcast by Sierra club with other EAC's next Monday. Will be published later on Spotify.
- Aaron clarification if we (EAC associate or full members) will be doing public speaking if you are representing as part of the EAC it needs to be brought up in the meeting before you have it.
- Feedback on the Toro commercial electric demo Public Works will be putting in a request to replace some of their equipment with electric equipment. In conversation, EAC will provide info on the savings and rebates for Public Works and the board. Aaron to work with Desiree and the contact the outside rep and Public Works to gather the data in the long term support of this.
  - Next steps for EAC : Education of commercial landscapers and residents on electrification of landscaping equipment.

- School District outreach Scheduled to meet in August, may be pushed off. Joy will connect 1 on 1 with Dr. Yannaconne. Will have a meeting in August with the students who've been engaged. Joy has also reached out to the Mount and LaSalle, some interest from them.
  - Joy to get a cert from Chuck to recognize Celia for her work with the EAC. Motioned and unanimous vote to approve that certificate of recognition.
