

2024 BUDGET OVERVIEW



EXPENSES

The PRELIMINARY 2024 general operating budget of \$19,646,947

\$949,796 or 5.1% MORE than adopted in 2023.

- Attributed to:
 - Increases in property & liability insurance costs, medical benefits, employee wages, waste disposal fees, and contributions to volunteer fire companies.
 - Offset by reductions to capital expenses, and projects funded by intergovernmental grants.

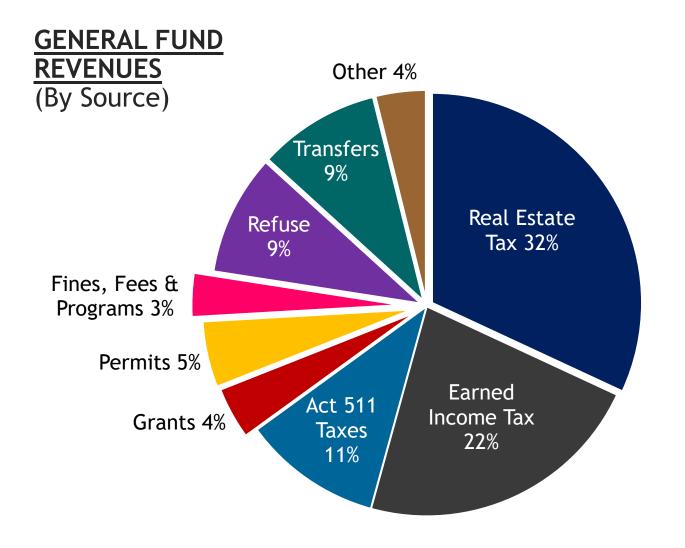

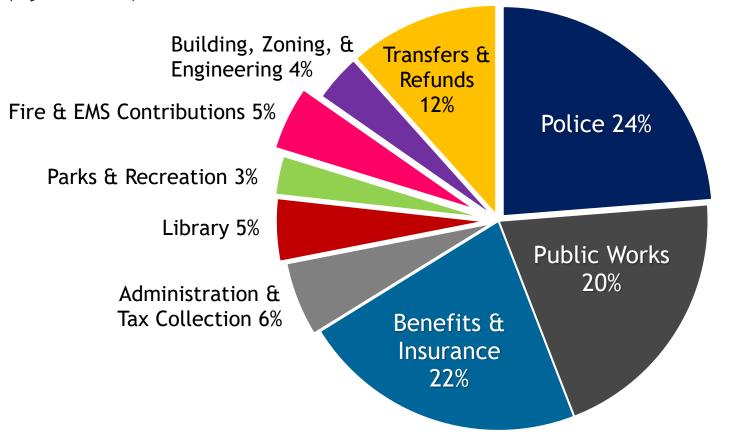
