INCIDENTS

1/15/24 – 100 block Emlen Way (Upper Dublin Township) – Springfield Officers responded to the area to assist the Upper Dublin Police Department with a male that abandoned his vehicle and fled on foot. Springfield units canvassed the area to locate the male but were unsuccessful and were then resumed to normal patrol operations. This incident is under investigation by the Upper Dublin Police Department as they are the agency having jurisdiction.

1/16/24 – 100 block Montgomery Ave – Officers were dispatched to the area after a patron noticed that their vehicle was broken into when sledding at Cisco Park. Unfortunately, a cell phone and wallet were stolen from the vehicle. Due to the time delay, and the reporting party no longer being on location, Officers couldn't locate a suspect.

1/17/24 – 1600 block Bethlehem Pike – Officers were dispatched to a local business for a male that was sleeping behind the wheel of a vehicle in a parking lot. While Officers were attempting to take the male into custody, he began resisting arrest. The Officers were able to arrest the male and transport him back to the station. While at the station, the male began repeatedly kicking the cell door ultimately damaging it. The male was transported to the Montgomery County Correctional Facility where he continued kicking the door to the police vehicle causing the door to begin to separate. The male was charged with institutional vandalism (for the cell door and police car door) and was held based on probable cause of driving under the influence.

1/21/24 – Unit Block Weiss Avenue – Officers were dispatched to the area for two juvenile males looking around cars and porches in the area. Officers canvassed the area along with Whitmarsh Township Police Officers to locate the males in question. The two males had fled the area prior to any Officers making contact. At this point, it does not appear that anything was stolen. Officers continued to canvass the area for any further activity.

1/21/24 – 300 block Plymouth Avenue – Officers were dispatched to the area for a male attempting to break into a vehicle. After a failed attempt, the male fled on foot toward Walnut Ave. Officers canvassed the area for an extended period but were unable to locate anyone matching that description. There were no other reports filed in reference to this and no items reported stolen.
