The approval of this application will allow for the replacement structure to be constructed to the rear of your home as per the plan submitted as Exhibit A-5, prepared by Matthew Piotrowski, RA and dated December 4, 2023.

The approval of this application was based on the testimony and exhibits entered into the record, which showed that the proposed addition would reduce the building and impervious coverages on the property. In addition, the proposed structure will be nine feet further from the floodway that the structure that was destroyed by the fallen tree. The decision was unanimous.
