

BID NOTICE

Notice is hereby given that the Board of Commissioners of Springfield Township, Montgomery County, PA, will receive sealed bids until 1:00 PM, on May 29, 2025, at which time they will be publicly opened and read aloud for the following project:

Avondale Road Stormwater Sewer Project

Interested Contractors may examine or obtain a copy of the Contract Documents during normal working hours at the SPRINGFIELD TOWNSHIP Municipal Building, 1510 PAPER MILL ROAD WYNDMOOR, PA 19038. The fee to obtain a copy of the contract documents is \$50.00.

A Mandatory Pre-bid meeting will be held in the municipal building at 1510 PAPER MILL ROAD WYNDMOOR, PA 19038 on Thursday, May 15, 2025 at 1:00 pm.

The Township seeks to install storm sewer inlets and 8-inch underdrain piping prior to road repaving later this summer. The project bidder is required to supply all equipment, manpower and materials to complete road saw cut, curb removal and disposal, installation of 8" perforated underdrain, 18" ADS storm pipe installation, Type C Inlets, connection of 18" ADS to existing inlet, trench restoration, and turf restoration.

Bids shall be submitted in a sealed envelope and shall be marked clearly as follows: **"Sealed Bid Proposal for Avondale Road Stormwater Sewer Project"**.

A certified check or bank draft, payable to the order of the Township of Springfield, negotiable U.S. Government Bonds (at par value), or a satisfactory Bid Bond executed by the Bidder and an acceptable surety, in an amount equal to ten percent (10%) of the total bid amount shall be submitted with each Bid. The successful Bidder will be required to furnish and pay for Satisfactory Performance and Payment Bond and Labor and Materialmen's Bond, each in an amount of 100% of the contract amount. A Certificate of Insurance showing proof of Workers Compensation Coverage shall be submitted. Prevailing state wage rates and Public Works Employment Verification Act will apply on this project.

The Township of Springfield reserves the right to reject any or all bids, and to make such an award as appears most advantageous to the Township. Springfield Township does not discriminate on the basis of race, gender, creed, color, sexual orientation, gender identity or expression. Bids may be held for a period of up to 60 days from the date of bid opening for the purpose of reviewing bids and investigating qualifications of bidders, prior to awarding a contract.
