Emergency Management: Bob Chiarlanza, EMC

The Board discussed in detail both the firefighting and emergency management aspects of the recent fire at SPS in Abington. The fire burned from 9:00 PM 2/17 to Sat. 2/22. All Township agencies were involved. There were many lessons learned on both the local and County levels including but not limited to: evacuations; refueling of apparatus; timing in regard to declaring a disaster; cleaning gear; and County employees fighting the fire and unavailable for there County assignments. In view of this incident the Board asked Comm. Lee for funding to conduct both desktop and a live drills to prepare for a large event.

The Board also discussed the incident at Wyndmoor Hills where patients were relocated to Springfield Residence due to a sewage blockage that involved several floors and the elevators. Again, all Township agencies were involved.

As a result of these discussions EMC Chiarlanza is to put together guidelines in regard to emergencies encountered in nursing facilities. Further, EMC Chiarlanza is to research establishing a resource to supply fuel to apparatus at a large incident.
